Derrick Street Booster Station Update – The station is now running and SCADA has been installed. There was a leak on the chemical injection line that has been fixed. The generator autotransmission switch still needs to be delivered.

Plant Pump House Pump #3 Upgrade – There was one bid received to install the larger pump. The bid was submitted by Pintail Contracting Services, LLC.

On a motion by Kenneth Dupaty, seconded by Calvin Steward and unanimously carried to pay invoice #23-1001 dated 2/6/2023 in the amount of \$11,924.00 to Process and Controls Engineering (Preliminary and Final Design Engineering, Field Measurement Survey and Plans/Manuals).

On a motion by Adam Mayon, seconded by Kenneth Dupaty and unanimously carried to accept the bid received from Pintail Contracting Services, LLC in the amount of \$196,700.00.

Plant #5 Addition Bond Project 2022 – The details are still being worked on and then the project will go out for bid.

On a motion by Wayne Arboneaux, seconded by Kenneth Dupaty and unanimously carried to pay invoice #9 dated 1/31/2023 in the amount of \$25,700.77 to Shread-Kuyrkendall & Associates, Inc. (60% Design Phase).

Administration Building/Board Meeting Room Bond Project 2022 – Donovan Duffy addressed the Board. He stated that they were still reviewing cost saving items. He informed the Board that the lowest bid was received from Del-Con, LLC in the amount of \$3,128,000.00.

On a motion by Kenneth Dupaty, seconded by Calvin Steward and unanimously carried to pay invoice #3 dated 1/31/2023 in the amount of \$21,495.90 to Meyer Engineers, Ltd. (100% Construction Documents, 100% Bidding Phase and 100% Geotechnical Work).

On a motion by Kenneth Dupaty, seconded by Blaine Mabile and unanimously carried to move ahead and approve the bid received by Del-Con, LLC in the amount of \$3,128,000.00.

Elevated Tower Rehabilitation Review Bond 2022 Project – There is currently a wait for the contract pertaining to the 3rd party inspection.
